Notice Of Race

Rules:

The regatta will be governed by the racing rules of sailing (RRS), the prescriptions of the United States Sailing Association, the by-laws and appendices of the Comet Class Yacht Racing Association (CCYRA) and the Sailing Instructions. (Anchor & line, paddle, and PFD's are required per CCYRA Specifications, Section 16.)

Eligibility, Entry and Waiver:

This event is open to CCYRA members who have paid their 2010 dues. Eligible yachts may be entered by mailing the attached FULLY COMPLETED Official Entry Form and Waiver and Release of Liability Form to: Bill Engels, 7 Dead End Road, Green Pond, NJ 07435. Sail Measurement:

During the registration period all sails are subject to measurement and to checking for CCYRA Sail Tax Labels. *[If you need Sail Tax Labels, contact Dave Seifert (614) 457-3094.]*

Sequence of Events:

This event has five (5) races scheduled, tentatively with four (3) to be sailed on Saturday, June 19, three (2) on Sunday, June 20. Three (3) races will constitute a series; if four (4) or more races are sailed, each yacht's poorest finish will be discarded. *[Sailing Instructions will be provided at the Registration Desk.]*
