3) ROOM & RESORT SERVICES/ AMENITIES

- Bedding in every room type is varied -with the bedding configuration and availability listed above. Rooms will be assigned based on the rooming list provided. Rollaway Beds, Cots are limited but available. Special Bedding requests to be included on the rooming list. All rooms have a private balcony, Cable Flat Screen TV, WIFI, Air Conditioning/Heat Unit, Small Fridge, Blow Dryer, Bathtub with Shower, Bathroom Amenities, Beach Towels, Blanket.
- Check in time is 3:00pm. Check out time is 11:00am. *Early check-in and late checkouts are <u>based on availability only</u>. Late Check Outs Until 1:00PM are not subject to a surcharge, from 1:00 3:00PM a \$100 surcharge and after 3:00PM full charge. Kindly advise the Resort in advance of arrival times / departure times in order that we may prepare accordingly. This request is based on availability.

Housekeeping Service

A once every third day housekeeping service is included in the rate depending on your length of stay ie. If less than 3 days housekeeping service will be daily. This housekeeping service a full clean which consists of cleaning of the entire room, fresh towels, replace all linens, trash removal and replace toiletries. Any additional cleaning services will be an additional charge of \$35 per room, per cleaning. If extra towels, and toiletries, are required, please call Front Desk or housekeeping. Additional Cleaning services not included will be billed to guest room incidental folios.

Laundry Service (Optional)

➤ The Resort can provide laundry service \$25 per Load. Guests will complete laundry form and drop of laundry bag with form to the front desk. The resort will wash and return Laundry to the guest's room the same day if submitted by 9:00am or Next day if after this time. All charges can be applied to the group master account or to the individual guest folios.

Meal Plan

➤ Willowbank Resort with a fully operational restaurant and fully staffed Culinary Team can execute food & beverage for the Group. We are pleased to offer a discounted **Sports Group meal plan of \$75.00 per person per day** to include breakfast, lunch and dinner. The discounted price can be added to the room rate and are inclusive of 17% F&B mandatory gratuity. Beverages are not included. Group Meals will be taken in the Ocean Dining Room and Terrace with predetermined menus. Meal Plan can be charged to the group master account or the individual room folios. Meal Plan inclusion with menus planned and provided upon contract signing.

Breakfast – Buffet to include executive Continental with One Hot breakfast item- to be varied daily.

Lunch – Simple Buffet or box lunches optional to include healthy choices.

4) USE OF WILLOWBANK FACILITIES

> Guests will have full use of all of Willowbank Resort amenities, services and facilities.

- ➤ Willowbank Resort Ocean Dining Room & Breezeway Grill will be open and operational for Breakfast, Lunch and Dinner. The Front Desk Snack & Sundry Shop will also be open for the group. Hours of operation will be provided.
- Willowbank Resort Amenities include: 2 Private Beaches, Outdoor Pool and Gym/Fitness Room. All amenities are included in room rate.
- Please note that it is against the law to smoke in public areas, which include our rooms. Guests can smoke outside, or on the balconies, but if there is any smoke damage a \$500 cleaning fee will be required in addition to the damage deposit.

6) ROOM DEPOSITS / PAYMENT SCHEDULE

- > Upon Confirmation: A deposit of 25% of the estimated total room charges is due.
- > 60 Days Prior to Arrival (DATES TBA): An additional 25% of the estimated total room charges is due.
- > 30 Days prior to Arrival (DATE TBA): An additional 25% of the estimated total room charges is due.
- ➤ 1 Week prior to Arrival (DATE TBA): Full balance of the estimated room charges and 50% of the group estimated planned F&B is due.
- > Upon receipt of Final Invoice (10 Days Post Check Out): Full balance of any additional and all charges is due.

7) CUT OFF DATES / ATTRITION / CANCELLATION

- ▶ 90 Days prior to Arrival (DATE TBA): Room block will be reviewed with Client and adjusted without penalty for attrition.
- ➤ 60-89 Days prior to Arrival (60 = DATE TBA): A 10% attrition or reduction of the adjusted room block from the 90 Day review is permitted without penalty. A 50% 100% reduction or full cancellation of the program within this time will result in a cancellation fee equivalent to 25% of the projected Room Revenues being cancelled.
- ➤ 31-59 Days prior to Arrival (30 = DATE TBA): An additional 5% attrition or reduction of the adjusted room block from the 60 Day review is permitted without penalty. A 50% 100% reduction or full cancellation of the program within this time will result in a cancellation fee equivalent to 100% of the projected Room Revenues being cancelled.
- ➤ 30 Days prior to Arrival: A complete rooming list is due at this time.

➤ 0-30 Days prior to Arrival (30 = DATE TBA): An additional 5% attrition or reduction of the adjusted room block from the 31-59 Day review is permitted without penalty. Any reduction above the 20% attrition, including no shows, late arrivals or early departures will be subject to 100% cancellation penalty.
