Rules:

The regatta will be governed by the Racing Rules of Sailing (RRS), the prescriptions of the United States Sailing Association, the by-laws and appendices of the Comet Class Yacht Racing Association (CCYRA) and the Sailing Instructions. (Anchor & line, paddle, and PFD's are required per CCYRA Specifications, Section 16.)

Eligibility, Entry and Waiver:

This event is open to CCYRA Junior members who have paid their 2018 dues.
A Junior is anyone who has NOT reached their 22nd Birthday before December 31, 2018.

Sequence of Events:

This event has five (5) races scheduled. One (1) race will constitute a series; if four (4) or more races are sailed, each yacht's poorest finish will be discarded. *[Sailing Instructions will be provided at the Registration Desk.]*

Sailing Conditions: The Shrewsbury River tends to have light to moderate winds in August. It is a tidal river with minimal current.

The CCYRA Junior Championship entry fee will be \$40. This will include dinner Friday and breakfast & lunch on Saturday. Trophies awarded to the top three positions for both skipper & crew. Checks are to be made payable to: Talbott Ingram
