Notice of Race

Rules:

The regatta will be governed by the Racing Rules of Sailing (RRS), the prescriptions of the United States Sailing Association, the by-laws and appendices of the Comet Class Yacht Racing Association (CCYRA) and the Sailing Instructions. (Anchor & line, paddle, and PFDs are required per CCYRA Specifications, Section 16.)

Eligibility, Entry and Waiver:

This event is open to CCYRA Junior members who have paid their 2019 dues. A Junior is anyone who has NOT reached their 22nd Birthday before December 31, 2019.

Eligible yachts may be entered by mailing the attached FULLY COMPLETED Official Entry Form and Waiver and Release of Liability Form to:

Sequence of Events:

This event has five (5) races scheduled. One (1) race will constitute a series; if four (4) or more races are sailed, each yacht's poorest finish will be discarded. [Sailing Instructions will be provided at the Registration Desk.]

Sailing Conditions: The Shrewsbury River tends to have light to moderate winds in August. It is a tidal river with minimal current.

Fees

The CCYRA Junior Championship entry fee will be **\$30 per boat.** This will include breakfast & lunch on Saturday. Trophies awarded to the top three positions for both skipper & crew. Checks are to be made payable to: **Comet Fleet 35**

There is also a **Junior membership fee of \$20 made payable to: CCYRA**. This is required for the skipper and encouraged for the crews.
